The website will be housed on the CPS website and will include the following core site components: 1) Curriculum Areas where parents can access relevant web resources; 2) Current Events Area where parents can find local activities for young children and families; 3) Communications Area (a Chat Room) where parents can find local activities for young children and families; 4) Communication links for preschoolers and their parents. Site content will be developed and provided by staff within the Office of Language, Cultural, and Early Childhood Education. Consultant has no payment for the time spent in the execution of the written agreement. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 60 days of the date of this Board Report. OBJECTIVES: Consultant services will result in the establishment of an interactive website available to parents and teachers which provides video lessons, information, and resources to support Early Childhood Education.

COMPENSATION: Consultant shall be paid as follows: 30% upon signing of the contract, 30% upon approval of final design, and remainder upon delivery of final product with the total compensation not to exceed \$74,000.
