GENERAL CONDITIONS

the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and to conduct those investigations that the inspector General shall have access to all information and personnel necessary for investigations.

Conflicts - The agreement shall not be legally binding on the Board if entered into in violation of the provisions of the Chicago Ethics Code, 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to former Board members during the one year period following the expiration or other termination of their terms of office.

Public Law 105-67 (95-6736-FY93) or amended from time to time shall be incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995 (95-0927 R) shall be incorporated into and made a part of the agreement.

The agreement shall contain the clause that any expense incurred beyond the current fiscal year shall be within appropriation of the proposed fiscal year budgets.
