
## APPROVE EXERCISING THE FIRST OPTION TO RENEW THE AGREEMENTS WITH VARIOUS VENDORS FOR THE PURCHASE OF EDUCATIONAL SUPPLIES

## THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the first option to renew the agreements with the twenty-seven vendors identified on Attachment A to provide specialized educational supplies to the Office of Specialized Services at an aggregate cost for the first option period not to exceed \$368,796. A written renewal agreement for each vendor is currently being negotiated. No payment shall be made to any vendor during the renewal term prior to the execution of such vendor's written renewal agreement.
