That the Chicago Board of Education approve the closing of Edward Franklin Frazier Elementary School ("Frazier") (Unit 7780), located at 4027 West Grenshaw Street, for academic reasons in accordance with the Policy on the Closing of Schools, 04-0225-PO2, and adjust the attendance areas of: Gregory Elementary School, located at 3715 West Polk Street; Sumner Elementary School, located at 4320 West Fifth Avenue; Webster Elementary School, located at 4055 West Arthington Street; and Henson Elementary School, located at 1326 South Avers Avenue, to include portions of the attendance area of Frazier Elementary School in accordance with the Policy on the Review and Establishment of School Attendance Boundaries, 05-0622-P01.

Frazier Elementary School satisfied the school closing inclusion criteria for the following reasons:

- 1. **Probation:** The school has been on probation since the 2004-2005 school year.
- 2. **2005 Scores:** The school's 2004-2005 ISAT Composite Score was 22.1% of students meeting or exceeding state standards; the school's 2004-2005 ITBS Reading Score was 23.1% of students



were: 26.6% in 2001-2002; 23.6% in 2002-2003; 27.5% in 2003-2004, and 22.1% in 2004-2005.

These scores give the school a 4-year average ISAT Composite Score of 25.0%.

Over the same period, the school's ITBS Reading Scores were: 25.7% in 2001-2002; 19.3% in
