Ratify entering into an agreement with Johns Hopkins University and approve payment to provide implementation and management of Diplomas Now services to Gage Park High School and John Hope

2013. The remaining \$280,000 will cover the cost for services in school years 2013-2014 and 2014-2015. The total cost is not to exceed \$420,000. These services were obtained without prior Board approval. These schools are participants in an I3 federal research grant sponsored by Johns Hopkins that provides them with school improvement support by implementing the Diplomas Now model to improve student outcomes. A written agreement for Vendor's services is currently being negotiated. No payment other than the payment of \$140,000 for services rendered through June 30, 2013 shall be made to Vendor prior to execution of the written agreement.
