CHIEF PROCUREMENT OFFICER DELEGATION OF AUTHORITY REPORT FOR JULY 2021 PURSUANT TO BOARD RULE 7-13(a) AND CHIEF FINANCIAL OFFICER REPORT FOR JULY 2021 PURSUANT TO BOARD RULE 7-13(d)

Pursuant to Board Rule 7-13(a) the Board of Education of the City of Chicago, Board Rule 7-13(a) delegated certain purchasing and contracting authority to the Chief Executive Officer, Chief Operating Officer, Chief Education Officer, Chief Financial Officer, Chief Procurement Officer, General Counsel, Board Rule 7-13(d) the Board requires that the Chief Procurement Officer submit a report of the authority exercised pursuant to that delegation ("delegated authority"). 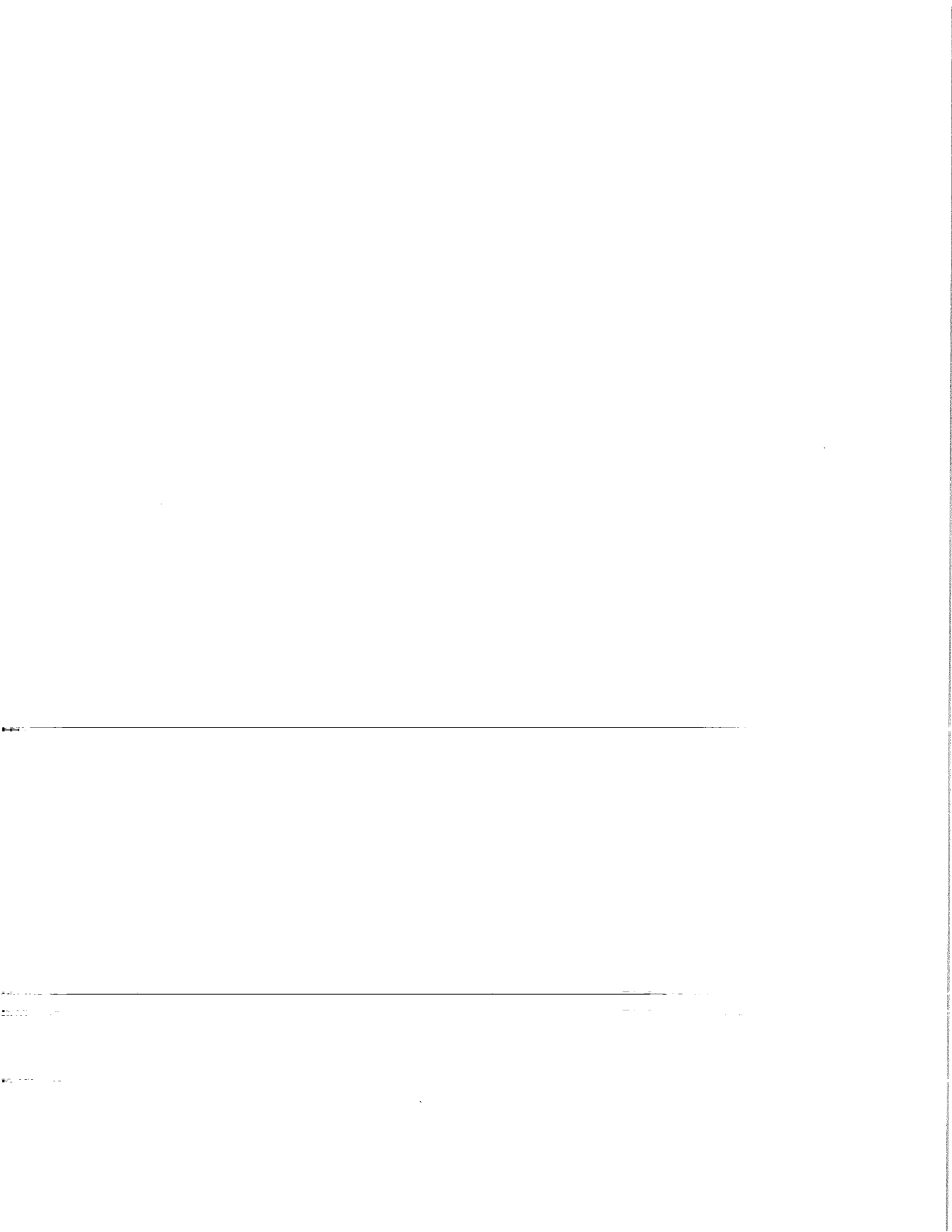
