## *Recommendation: Non-Renewal*

*An Urban Prep executive according to the IG report, violated the law including:*

*Title IX of the Elementary and Secondary Education Act Amendments of 1972 by sexually touching and grooming a student*

*Title VII of the Civil Rights Act of 1964 by conditioning his employment on a sexual relationship, as well as*

*Other laws with respect to use of public funds that put student and staff safety, and well-being at risk.*

*Urban Prep has failed to meet generally accepted standards of fiscal management*

*Urban Prep violated its charter with CBOE by: ignoring express pre-conditions for the renewal of its*
